## Chamber's Government Affairs Committee Hosts Candidate's Forum

The Government Affairs Committee of the Pocono Mountains Chamber of Commerce hosted a candidate's forum for the 176th State House District on October 14, 2004. The forum was held at the Best Western Pocono Inn in Stroudsburg, and was televised live by Blue Ridge Cable TV, Channel 13. Moderator for the event was George Roberts of Channel 13.

Questions from the three panelists covered a wide range of topics from tort reform and real estate fraud, to jobs, commuter rail, growth, and property tax relief. Questions from the audience were also presented to the candidates. The audience packed the ballroom of the Best Western Pocono Inn. This one hour forum was standing-room only due to the large turnout. Co-sponsors for this forum were the Pocono Record, Blue Ridge Cable TV, and the Best Western Pocono Inn.

The 176th State House District represents approximately 60,000 residents of Stroudsburg, East Stroudsburg, and the Mount Pocono boroughs of Jackson, Pocono, Paradise, and Coolbaugh Townships. It also represents Districts 2,3, and 4 of Stroud Township.

Since 2001 the Government Affairs Committee of the Chamber has hosted five live televised candidate's forums for state and county legislative races. The Chamber is has made a commitment to continue hosting political forums in the future as a public service for the voters of the Pocono Mountains region.
