was a woman from the WilkesBarre area who chose to have

Recently, Pennsylvania Governor Ed Rendell announced that Johnson & Johnson, the New Jersey based manufacturer of health, medical, and pharmaceutical products, will open a 1.37 million-square-foot distribution center in Coolbaugh Township later this year. It is estimated that this distribution center will create several hundred new jobs for the region.

This project received a \$1.6 million in funding from the Department of Community and Economic Development, in addition to an \$800,000 grant and \$804,000 in job creation tax credits. Additionally, this will be the first major project to open in the business park, off Route 611 near Pocono Mountains Municipal Airport.

The Chamber supports projects like this one that provide new jobs for our area. We believe that this new facility will help promote and attract other interested companies who are looking to relocate to our region. This is another fine example of effective economic development for Monroe County.
