# UMEZ Delivers \$500,000 to Acción New York

The Upper Manhattan Empowerment Zone Development Corporation (UMEZ) and ACCION New York announced the capitalization of a \$500,000 micro-loan fund dedicated to small entrepreneurs and local businesses in East Harlem. The micro-loan fund subsidized by UMEZ will provide loans to small businesses located in East Harlem ranging from \$500 to \$50,000 at a favorable annual interest rate.

The UMEZ/ACCION East Harlem microloan program will be administered by

ACCION New York and offers a unique 7% - 9% per annum rate on its loans for East Harlem businesses located in Community Board 11. The low rate is made possible through a separate grant that was also provided by UMEZ to cover many of the direct costs of providing credit to micro-lenders. ACCION New York will continue to administer About ACCION New York its lending program outside of Community Board 11 under its normal parameters and fee structure.

"This is a great partnership and will get much needed capital into the small business community of East Harlem," said Kenneth J. Knuckles, CEO and President of UMEZ. "ACCION New York offers us a partner with a proven track record in providing micro-loans to area businesses that would otherwise not qualify for conventional financing or may be forced into an informal lending market known for usurious ratés."



"ACCION New York is very excited about this first step toward a larger partnership with UMEZ," said ACCION New York President and CEO, Robert A. Espaillat. "We have been lending to East Harlem and Upper Manhattan for many years but the lower rate, combined with the joint marketing and outreach efforts of the two organizations, will greatly enhance our ability to provide funding to local businesses."

The UMEZ/ACCION East Harlem micro-loan fund will be directed by a team leader who will coordinate five loan consultants that will

be based at UMEZ's offices located at 290 Lenox Avenue, 2nd Floor, New York, NY 10027. To contact a loan officer about the micro-loan program, please call the Loan Inquiry Line at (212) 387-0494.

ACCION New York works with self-employed individuals who lack access to traditional forms of business credit. By providing credit and other support services to micro-entrepreneurs, ACCION New York seeks to increase business and family incomes, create jobs and revitalize the economically disenfranchised neighborhoods of New York City. Founded in 1991, ACCION New York has emerged as the city's largest micro-lender, having disbursed over 5,000 loans totaling more than \$25 million to 3,100 small business owners and entrepreneurs.



# RESTAURANT SERVICE WORKFORCE PROGRAM (CO-SPONSORED BY UMEZ)

In our efforts to create employment opportunities for community residents, the Upper Manhattan Empowerment Zone recently held a Restaurant Training Initiative (RTI). The RTI represented a cdlaborative venture between community stakeholders and UMEZ. Specifically, two organizations — the local One Stop Career Center and the soon-to-open Dinosaur

Bar-B-Que restaurant — worked with UMEZ to identify, train, and help place workers interested in jobs in the restaurant industry.

The Restaurant Training Initiative provided participants with an introduction to the restaurant industry as well as training, skills development, and a career tool kit, to help them develop employable competency for the workplace. The Restaurant Training Initiative was held



over a four week period (late August through early September) at the local One Stop Career Center. Seminars consisted of topics

that emphasized but were not limited to the following: proper silverware wrapping techniques, proper table settings, safety tips for carrying large dish trays, and ordering sales techniques.

One particularly exciting component of the Restaurant Training Initiative was the participation of Dinosaur Bar-B-Que. Working closely with Dinosaur's ownership, UMEZ designed its RTI with a detailed knowledge of the Bar-B-Que business. What is more, UMEZ assumed a pivotal role in attract-

ing Dinosaur Bar-B-Que to the Harlem community. In the future, UMEZ hope to replicate efforts that allow it to link job creation to its business development activities.
