The following is a brief outline of my extensive background and qualifications and my general consultation procedures.

I received my Doctor of Osteopathy in 1958 from the Chicago College of Osteopathy in Illinois. I received my Honorary MD degree from the University of California Irvine in 1962 and completed my Radiology Residency from Mt. Zion in San Francisco, California in 1964. For many years, I was the Medical Director of Mineral Lab in Hayward, California, a leading laboratory for trace mineral analysis worldwide. I am on the Board of Homeopathic Medical Examiners for Arizona, am Co-Founder of the American College for Advancement in Medicine (ACAM) and am on the Scientific Advisory Committee for the Board of the National Foundation for Alternative Medicine in Washington, D.C.

I am Founder and President of the International College of Advance Longevity (ICALM) and Board Member of International Oxidative Medicine Association (IOMA). With Morton Walker, DPM, I co-authored *The Chelation Answer*. I am an advisor to the American Board of Chelation Therapy and past instructor and examiner for all chelation physicians. I am also responsible for Peer Review for Chelation Therapy in the State of Arizona. As an internationally recognized expert on chelation therapy, I am now attempting to establish standards for the proper use of oral chelation therapy as an adjunct therapy for all diseases. I lecture extensively across the globe on the "End of Bypass Surgery is in Sight" and "The New Chelation".

Currently, I am a full-time consultant for nutritional supplement companies, one being Longevity Plus, located in Payson, Arizona. I am responsible for the formulation of the majority of their supplements, which are widely used by alternative health practitioners around the world. Concurrently, I specialize in telephonic consultations recommending alternative therapies, supplements and oxidative treatments.
