GOVERNOR RENDELL'S "PRESCRIPTION FOR PENNSYLVANIA"

Governor Rendell introduced a comprehensive health reform plan in January 2007 intended to provide access to affordable, quality health care for all state residents. It features an individual mandate on those with income above 300 percent of the federal poverty level, and a "Cover all Pennsylvanians" (CAP) program that offers basic, private health coverage to small businesses and the uninsured, with subsidies for lowerincome people. The plan calls for all employers who do not provide health care insurance for their employees either privately or through the CAP program to be charged a 3% tax on their total payroll.

This proposed payroll tax on business is considered to have a major impact on employers who already cannot afford health care insurance for their employees. However, employers who currently provide employee health care coverage may consider paying the 3% payroll tax, because it would be more financially beneficial than current costs. Studies show that health care insurance coverage comprises 15 to 20% of payroll, with total benefits comprising 41.6% of payroll, for Pennsylvania employers.

The Prescription for Pennsylvania includes more effective regulation of the insurance industry to protect small businesses and individuals from extraordinary spikes in health care premiums. It will implement adjusted community rating, which prohibits using certain demographic characteristics such as health status and gender, in rate setting.

In addition, Governor Rendell's plan promotes a common-sense payment system that rewards wellness and stops paying for unnecessary or ineffective medical services. And to help all Pennsylvanians stay healthy, the plan includes consumer incentives that reward healthy lifestyles.

The Chamber has not taken an official position on the proposal. However, we will continue to monitor House Bill 700 which contains the Governor's plan.

I Just Hired A Punk Rocker, Now What?

Question: I recently hired a college student as a part-time employee for the summer. He wasn't wearing an earring when I interviewed him. Since he started, I've asked him to remove the earring. Can I lawfully fire him if I allow female employees to wear earrings?

Answer: Most likely, yes. As a business, you understandably may be concerned about the image your employees project to customers and the public. You may also have safety or other legitimate concerns.

Under the case law (including a case involving a male optometrist in Stroudsburg) an employer may establish and enforce different appearance requirements for male and female employees based on "accepted community standards." So long as both sexes are generally subject to appearance-based requirements, the specific requirements for the sexes may differ to reflect customary modes of grooming and personal appearance.

In short, it's a good idea to develop and reduce to writing a grooming or appearance policy, communicate it to all employees, and enforce it even-handedly, even as to any sex-specific requirements that may be included.

From the President



Two of the top concerns for small businesses in today's market are insurance costs and taxes according to a recent Wells Fargo/Gallup Small Business Index Survey. Nearly 65% of those businesses surveyed said that the cost of insurance is a primary concern, while 62% cited taxes. Forty-five percent said that the government regulation is a major concern.

The U.S. Chamber of Commerce has felt that policymakers should free up more resources for small business growth and job expansion by making permanent the Bush tax cuts, including repealing the death tax, and creating new ways for small firms to access affordable health insurance.

It is no surprise that nine out of 10 small business owners who established a business plan for 2007 said that increasing sales and revenues is a high or very high priority. Accordingly, cutting operating expenses was identified as a top goal, followed by developing new products or services, reaching more customers, increasing advertising, and investing in technology.
