HR Corner

Are you selecting a Staffing Agency and/or other company where there will be a workforce not employed by your company? If so, here is a list of questions pertaining to the I-9 that will help you in the selection process.

What are their procedures for collecting valid identification for the I-9?

Do they have a process for following up on registered aliens whose I-9 has an expiration date? Do they have a tickler system in place? A reporting tool - that is reviewed monthly? Who notifies the employee?

Do the people we do business with follow the law?

Does the employer have an auditing process in place to ensure all employees are correctly registered with an I-9? Are they doing internal/external auditing routinely? Who does the audit?

Are you accepting laminated social security cards?

According to the INS Handbook for Employers, you may not accept a laminated SS card as evidence of employment eligibility if the card states on the back NOT VALID IF LAMINATED, metal or plastic reproductions of SS cards are not acceptable.

Does the agency provide training to its employees on the proper procedure for completing an I-9? Are they consistent? You must examine the documents and then, if they appear to be genuine and relate to the person presenting them, accept them.

Are they ISO certified? ISO is a third-party evaluation system which represents a set of standards for quality management. The agency must also have a proven system for continuous improvement.
