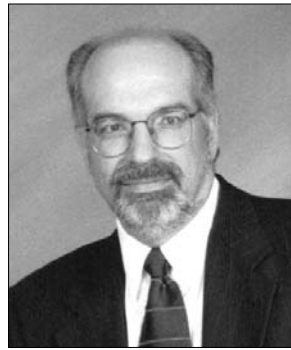

ECONOMIC ADVISORY BOARD

I have been very fortunate in my career and community life to do many things that have had an impact on a significant number of lives in the Monroe County Region. I have written about many of them in past Impact Articles, however there is one activity that stands out the most to me - my involvement with the Economic Advisory Board (EAB).

The EAB was formed as a result of the successful Monroe 2020 effort that created a complex strategic and tactical program that focused on the growing population, rising taxes, and land use practices of Monroe County. This Program created the foundation for the EAB through a community partnership of many citizens and civic leaders in the county.

The Monroe County Board of Commissioners took the next step, which was to develop an Economic Advisory Board whose mission is to create a long-term plan for economic growth and prosperity in Monroe County by applying the data obtained from the Monroe 2020 activity as a baseline.

The EAB consists of a wide variety of business people from many industries, among them - resort and hospitality industry, academia, government agencies, non-profits, as well as small and large businesses.

The EAB has been broken out into nine different focuses and sub groups, each of whom is gathering data and making recommendations on the following: Infrastructure, Economic Base, Economic Vitality, Government and Business Climate, Financial Support, Promotion, Physical Geographic Constraints, Manpower, Information, and Education Outreach.

The EAB believes that economic activity does not stop at jurisdictional borders i.e. local, state, and national. We here in our county are part of a global, mobile economy. EAB is focusing on an analysis of linkages of activities, each of which adds value to the chain. It is important that we all work together to harness the creativity of our people in this region. The EAB's job is to assess, plan and facilitate action within our locality by recommending efforts aimed toward continuous improvement to the quality of life in our region.

The Economic Advisory Board believes in the vision and the opportunities of a future driven by the power of ideas. Everyone's Ideas. Remember: No One Alone Is As Strong As All of Us Together.

From the President

I recently had the honor of teaching at the Northeast Institute of Organization Management at Villanova University in Philadelphia for the second year. I feel very fortunate to have had the opportunity to facilitate three courses, which included Economic Development, Sponsorship Solicitation, and Secrets of Successful Chamber Executives. I would like to share my experience with you, touching briefly on each of these courses.



Economic Development focuses on the executive determining how their downtown area is currently structured, and identifying ways to establish both retention of current businesses and growth of new business. The executive learns how to do this by structuring and implementing an economic development plan. As a result of this, they learn how to make their community a better place to do business.

Sponsorship Solicitation is structured to focus on sponsorship of events, publications, and programs. This class primarily deals with how sponsorships can play a major role in increasing revenue. The executive learns how to structure sponsorship opportunities, develop a price, and solicit the right organizations to meet the company's goals.

Secrets of Successful Chamber Executives teaches the executive how to have continued success as a chamber executive. This class includes ways to become recognized, tips on career and organizational success, and how to clarify their role in the community. After completion of this course, the executive should have a more clear understanding of how to avoid setbacks and become a prominent industry leader.

I was also afforded the opportunity to be the guest speaker for the fourth year class on the topic of "Career Mapping."

More than 190 executives attended the Institute from both the Chamber of Commerce industry and major associations in the country. These courses will help executives explore professional advancement for their Chamber of Commerce career. The Pocono Mountains Chamber of Commerce is deeply committed to being the leading business organization, and providing a unified voice for its members.
