Dear Donors, Volunteers and Friends,

Your support of the United Way of Monroe County's 2010 Campaign is greatly appreciated. You make the difference by giving of your "time, talent and treasure" to advance our vision of Monroe County to be a community of thriving children, healthy families, self-sufficient people and vibrant neighborhoods.

The funding decisions made by the 47 volunteers (adults and students), are summarized in the 2011-2012 Fund Distribution and Youth Allocation Report. These volunteers review the partner agencies' applications for funding of programs which deliver services for the four need areas – Meeting Basic Needs, Helping Children Succeed, Promoting Self-Sufficiency and Engaging Youth - identified by the United Way of Monroe County. The volunteers also visit the agencies to discuss their programs and outcomes. Using a donor survey as a guideline, the percentage breakdown of the undesignated (not donor-directed) dollars, that constitute the United Way Community Fund, is allocated to each need area. Each panel discusses and makes decisions regarding the funding of the programs for their need area. The rationales for the funding and recommendations to the agencies are included in the full report, which is available at www.unitedwaymonroe.org.

Agency requests for programs to be funded reviewed by the four panels decreased to \$790,530, or 14.2% less than the prior year. The total of the Community Fund, or undesignated dollars, slightly decreased this year to \$466,459, or 10% less than the prior year. The total of donor designated (donor-directed) dollars increased to \$112,567, a 5% increase, and the estimated uncollectible pledges was increased to \$36,130, due to the ongoing serious economic situation and continuing high unemployment in the area. Youth Allocations, which are grants given to projects run by our partner agencies that focus on children and youth, remained the same as last year at \$10,000.

The funds requested from the Community Fund continue to exceed the funds available to allocate. The panel volunteers were challenged by the funding limitations but focused on the community's greatest needs and demonstrated program outcomes from our partner agencies that are meeting these needs.

The hundreds of people and businesses that contributed their time and treasure in supporting the 2010 campaign are sincerely thanked. We also give our heartfelt thanks to the many volunteers that served on the allocations panels and special thanks to the high school officials and parents for supporting the students who served on the Youth Allocation panel.


